*USEA TESTS ARE PERMITTED BUT CADS WILL GIVE PRIORITY TO ITS MEMBERS AND USDF TESTS. YOU MAY CHOOSE A USDF TEST OF CHOICE TO RIDE IF USEA TESTS MUST BE CUT, WRITE ON ENTRY FORM.
